

### Industry Intelligence & Commentary

April 09: Hilton Worldwide, the US-listed hotel owner and operator, announced that HNA Group, the China-based conglomerate, has commenced a secondary offering of up to 72.5M shares of Hilton's common stock. In addition to the offering, Hilton announced that it has entered into an agreement with HNA to repurchase 10M shares, with the option to increase the size to 16.5M shares, prior to the pricing of the secondary offering. Hilton's share repurchase price will be equal to 99% of HNA's secondary offering price, less all underwriter discounts and commissions per share.

April 05: Funds managed by The Blackstone Group, the US-listed asset management group, have entered into an agreement to acquire 16.56% of Hispania Activos Inmobiliarios, the Spain-listed real estate investment trust, from funds run by George Soros for  $\leq$ 315.4 million. Concurrently to the announcement, the same funds made a voluntary all-cash takeover offer for the remaining shares of Hispania at  $\leq$ 17.45/share, equating to a total equity value of approximately  $\leq$ 1.9B (approx. US\$2.3 billion), which is subject to the funds becoming the owners of at least 50% plus one share of the group pursuant to any transaction.

April 05: AccorHotels, the France-listed hotel owner and operator, announced plans to buy a 50% stake Mantis Group, the South Africa-based travel group with five-star properties and lodges around the world, for an undisclosed amount.

April 04: Iconiq Capital, the US-based investment group, has reportedly acquired an undisclosed stake in the 273-key Taj Boston from the existing ownership group, which includes New England Development, the US-based real estate development group, Eastern Real Estate, the US-based real estate development group, Lubert-Adler, the US-based real estate investment group, Rockpoint Group, the US-based real estate investment group, and Highgate, the US-based real estate investment and management firm, at a valuation of US\$196 million (approx. US\$718,000 per key), according to the Boston Business Journal.

April 03: A joint-venture between Banyan Tree Holdings, the Singaporelisted hotel developer and operator, and China Vanke Co, the China-listed real estate developer, has reportedly acquired a 19-hotel portfolio of Banyan Tree hotels across China, including two development properties, from an undisclosed seller for approx. US\$214 million, according to the Business Times.
